“TO THE HILL!”



Since there is a Board meeting on the same day as deadline and also since there is so much going on legislatively right now, I am forced to use my currently weekly wrap up as my Legislative Report for April's newsletter. If you're not on the email list, then it will be 20 days old info but still new to you. (You can sign up for my weekly wrap-ups by sending an email to our PR/Communications Officer Carol Simpson at csfreedom@aol.com.)

It turns out that the second week of March is going to be a big week for motorcyclists at the Capitol! Of course the following week is our Lobby Day and that will be a huge week as well. And of all the darned coincidences... March has been declared the Brain Injury Awareness Month by the Governor. Very exciting stuff this month has turned out to be!

Our Liberty bill successfully passed out of House Transportation Sub-committee last Wednesday. A lot of white coats and departments filled the room. They were not surprised as it was well known that we had the votes to leave the subcommittee.

Both helmet bills (our Liberty Bill-HB0894 and the merchant's helmet bill-HB0044) are set to be heard in both Senate and House Transportation Committees THIS WEEK.

Here are the locations and times:

House Full Transportation on Tuesday, March 12th at 1:30pm in LP16
Senate Transportation on Wednesday, March 13th at 1pm in LP 12

If you can be there Tuesday, we need all the motorcycle support we can get. Please plan to arrive early to get a seat. You will have

to pass through security to obtain a temporary pass with your photo ID. It can be a time delay.

We are sure there will be lots of opposition present. Your presence will not only be great moral support for your lobby team, it will be great back up for the members of Committee voting on your potential future liberty.

As if we did not have enough going on, the mandatory minor rider education (MMRE) bill - HB0428 - has been put on notice for Wednesday's Senate Transportation Committee at 1pm and the House Transportation Subcommittee at 1:30pm. Our official Position Statement can be found on the legislative page of the website.

We do not support this bill and will be providing our Position Statement to the members of the Committees this week. The Legislative Committee decided that we would not support the bill based on three reasons:

Lack of availability to many rural communities;

Financial burden of \$250 when parents can and do train their children how to ride with far more hours than a weekend course; and

Most importantly, we believe the bill has more to do with governing parenthood than governing transportation and safety.

This policy in other states that have a limitation of resources for their citizens has proven to be the likely cause of an increased unendorsed minor accident and death rate. As the authoring organization of the MREP program, safety training is high on our list of support. We simply do not believe it is the government's place to mandate training to one sect of the public and not the full public.
